Our 2025/26 budget ensures that we can continue to deliver services that support those residents most in need, improve our local communities, and improve people's everyday lives.

Surrey County Council is responsible for a wide range of things including Adult Social Care, Children's Services, Education, Highways and Transport,

Libraries and Culture, Public Health and Surrey Fire & Rescue Service.

The council will also be delivering a huge level of investment in the county, including new children's homes, care accommodation, improved roads and town centre infrastructure, and community-led projects.

All to make Surrey a better place.

The average Band D Council Tax per year is £1,846.35*, here's how your money is spent:

FINANCIAL MANAGEMENT

We are proud that we can set a balanced budget and protect our services in a tough economic climate, thanks to years of strong financial management.

However, with higher costs and higher levels of demand on our services, we must increase Council Tax as our main source of funding, as well as deliver cost savings across our budget.

This will help us make sure our services can continue to be delivered.

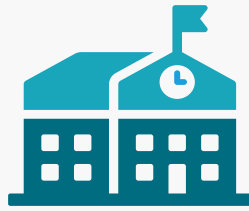
In order to achieve a balanced budget, councillors have approved a Council Tax increase of 4.99% (made up of 2.99% increase in the core Council Tax and 2% increase on the Adult Social Care Precept).

The increase of £1.69 per week for the average Band D Council Taxpayer (£1.01 on core Council Tax and £0.68 on Adults Social Care Precept), will help support our most vulnerable residents and keep Surrey a great place to live.
