How does a Residents Parking Zone (RPZ) work?

During the controlled times only vehicles displaying a valid Resident Parking Permit, or a valid Visitor Permit will be allowed to park in the parking bays. However, it is important to understand that **a permit does not guarantee a space**.

Any single or double yellow line restrictions which apply outside the controlled operating times must be observed by all residents, including those with a residents parking permit.

Except where no loading or unloading restrictions apply, vehicles can stop in bays and on yellow lines in the RPZ long enough to pick up or drop off passengers or to load and unload bulky items, as long as no obstruction is caused. Blue badge holders can park in any parking bay as long as their blue badge is displayed correctly.

Who is eligible for a Resident Permit?

Only residents living within an RPZ can have a Residents Permit. The vehicle must be registered to the address within the RPZ. However, restrictions will apply depending on the number of off-street parking spaces available at the property (see below). Your permit is only valid for the zone in which you live.

How many Residents Permits can I apply for?

The number of permits Epsom & Ewell Borough Council can issue to a property is calculated as the total number of vehicles registered to members of the household resident at that property, minus the total number of off-street parking spaces available at the property.

How much do Residents Permits cost?

Permits cost £50 for the first vehicle and £75 for any subsequent vehicles. They are valid for one calendar year from the date of issue.

What happens if I lose my permit?

You can apply for a replacement permit, which will cost £15 and be valid for the same period as the original permit.

What happens if I change my vehicle?

You can apply to amend the registration details of your vehicle, which will incur a £15 administration charge. The original parking permit should be surrendered to the Council and the new permit issued will be valid for the remainder of the period stated on the original permit.

Can any type of vehicle have a permit?

Only vehicles of a type and class detailed in the Traffic Order are eligible. Generally these are passenger vehicles and goods vehicles weighing less than 5 tons.

What happens if I move away?

You will need to return your Residents Permit(s) to the Council, after which you will be given a pro rata refund, calculated in full months. Unused visitor permits are not eligible for a refund.

What do I do about visitors and workmen?

Residents can buy scratch card visitor permits in advance, either in books of 10 cards for \pounds 20 or individually at \pounds 2 each. Please note each property is allowed a maximum of 120 permits in a rolling 12 month period.

What do I do about visitors attending for medical/care reasons?

Healthcare or community visitors can apply to Epsom & Ewell Borough Council for a Medical Permit. They will need to complete an application form, provide proof of their employment in this capacity and details of the person and address they are visiting.

What do I do about home care visitors?

You can apply for a carers permit by completing a Carers Application Form. You will need to provide a letter from the care provider to confirm that daily home care is required. If you live in Zone G a fee of $\pounds 10$ is applied, in all other zones there is no application fee.

How will you enforce the RPZ?

Civil Enforcement Officers are employed by Epsom & Ewell Borough Council to carry out regular patrols within the borough, including the RPZs. Vehicles parked in the RPZ without a valid permit or visitors permit displayed will be liable to receive a Penalty Charge Notice (PCN).

How do I apply?

Complete the enclosed application form, and return it to Customer Services at the Town Hall, The Parade, Epsom, KT18 5BY. Payment can be made by calling Customer Services to pay by debit or credit card or by enclosing a cheque with your application, as detailed in your invitation letter.

You will need to provide two proofs of your residency dated less than 3 months old, and the vehicle registration document (V5C) showing the address within the zone, to prove ownership of the vehicle.
