**Title of Document**

The title of the document that is subject to Publication and which the local planning authority intends to submit to the Secretary of State is: Proposed Submission Epsom and Ewell Local Plan 2022 - 2040 (Regulation 19)

**Subject Matter**

The Proposed Submission Local Plan (Regulation 19) sets out the long-term vision and strategy for the level and location of new development in the Borough over the period up to 2040. It makes provision for new housing, employment and other development needs including infrastructure to support growth in an inclusive and sustainable way. It contains planning policies and site allocations which will be used to determine planning applications in the Borough.

**Area Covered**

The Proposed Submission Local Plan covers the whole of the administrative area of the Borough of Epsom & Ewell.
